GRAFTON UNITED CRICKET CLUB INCORPORATED CONSTITUTION – SUMMARY OF PROPOSED CHANGES

ANNUAL GENERAL MEETING, 22 JULY 2025

BACKGROUND:

- Changes to the GUCC's constitution (rules) are required to comply with the Incorporated Societies Act 2022.
- Societies are required to re-register before 5 April 2026.
- Re-registration requires filing a constitution that is compliant with the new Act.
- Changes to GUCC's constitution are made through a resolution of members at a General Meeting.
- This document is a summary of the key proposed changes.

- Changes have been informed by Sport NZ and New Zealand Cricket (NZC) guidance and templates. More: <u>Refer to Sport NZ resources</u>.

Additions to Annual General Meeting	 6.1. Additions to the business of the AGM including giving notice of disclosure of conflicts of interest. 6.1(d) Addition of 10 days' notice prior to AGM of any proposed motions 6.1(e) Additional of 10 days' notice prior to AGM for the agenda to be sent to all persons entitled to attend the AGM. 	Ensures the correct information is presented at the AGM. Under the 2022 Act, there is a requirement for the time within which, and manner within which, notice of motion must be notified to Members. There is also a requirement for the agenda of the AGM to be sent out prior to the AGM.
Addition to Manner of Holding Meetings	6.3(e) Addition of a requirement to keep minutes at General Meetings	Under the 2022 Act, there is a requirement to state when minutes are to be kept.

Officer nominations made in writing by 2 members at least 5 days' before the AGM	Additional change (not related to 2022 Act) to align with accepted practice. Ensures Officers and Members have opportunity receive nomination information prior to the AGM.
Accounts shall be audited by an auditor	10.3 and various. Update to provide for accounts be audited by an auditor or reviewed by a qualified reviewer	Additional change (not related to 2022 Act) to align with accepted practice. A full audit is no longer required to meet Auckland Cricket Association requirements. A review by a qualified reviewer shall be undertaken.
Seal (Clause 12)	12. Seal requirement removed	Under the 2022 Act, a Seal is no longer mandatory.
Addition	13. Addition of Dispute Resolution Clause	It is a requirement under the 2022 Act for there to be a dispute resolution procedure in the Constitution. This has been adopted from a Sport NZ template.
"Winding up" Clause	15. Deletion of "Winding Up" clause and replacing with "Liquidation and Removal" clause	Wording changed to be consistent with 2022 and to also incorporating the new requirement under the 2022 Act for the surplus assets of a club to be distributed to one or more not-for-profit entities. Auckland Cricket Association has been nominated as an organization that shares a similar purpose to the Club.
